

GUESS AND WIN COMPETITION TERMS AND CONDITIONS

Participation in this promotional competition is governed by these terms and conditions, a copy of which is available at www.asksecurity.co.za and. All participants entering this promotional competition agree that the competition rules set out in these terms and conditions are binding on them.

The promoter of this competition is ASK Security cc ("ASK Security"), and ASK Security reserves the right in its sole discretion and to the extent permitted by law, to amend these terms and conditions at any time.

Each participant acknowledges that by entering this promotional competition, he/she has been given an appropriate opportunity to read these terms and conditions before entering the promotional competition and that he/she understands and agrees to these terms and conditions.

These Rules shall be governed by and interpreted according to the laws of the Republic of South Africa and any participant and ASK Security consent to the non-exclusive jurisdiction of the High Court of South Africa.

By participating in this competition, entrants agree to the terms and conditions set out below.

1. This competition is only open to residents of the Western Cape, South Africa (all participants must hold valid identity documents). In addition, the following people shall not be eligible to participate in this competition:
